- a. Discussion of solicitation of donations via donation box: Kathi brought in a box for donations. It will not be out at children's events. Judy moved to reimburse for the box and put the box out as appropriate at Friends sponsored events. Sue seconds. Vote was approved. Motion carried.
- b. Discussion of MiniGolf fundraising event: This was a very emotional and complicated discussion.
 - b.i. Some points were very clear: This is not a library event. This is a Friends event. The staff is already tapped out with other obligations. Mike is not running the event.
 - b.ii. Other notes: The Friends have moved forward with new fundraising events. There was a suggestion of making it a summer event but people seem to like it on the February Sunday the week before the Super Bowl. Mike has someone who is willing to solicit donations. If anyone is asking for donations or working on the Friends behalf they must be a member. We don't know who these volunteers are and we don't

know what will be asked of the Friends as we get closer to the event. Members are not against mini-golf but skipping one year has been a settled issue for months while we explore new income streams. Members are not happy that the topic was brought up after the meeting was over last month and the majority of people had left when it could have been discussed during the meeting. When we asked around the room if someone wanted to chair the event, there were zero volunteers. There was a disagreement on how much work the chair has to do in the leadup and day of the event. During the meeting, Mike said that he found a volunteer to be the chair. Last year's event brought in approx. \$4200. Mike is concerned about how we replace that along with any federal budget cuts. There was a question of what to do with the raffle. Hold it at the mini-golf event or have the drawing at the book sale in March.
